**PUBLIC NOTICE**  
**POLLING PLACE BUFFER ZONES FOR TRANSYLVANIA COUNTY POLLING PLACES**  
**NOVEMBER 6, 2018 GENERAL**

The following is a list of Transylvania County polling places for the 2018 General and a description of each buffer zone in which One-Stop Early Voting and Election Day electioneering is prohibited. Buffer zones are designated in accordance with GS 163A-1134(a), by the county board of elections. Where practical, the set limit of the zone is 50 feet from the door of entrance to the voting place, measured when that door is closed, but in no event is the limit at more than 50 feet or at less than 25 feet. The poll workers will mark buffer zones during One-Stop Early Voting and on Election Day with survey flags, chalk lines, and/or "No Campaigning" barricade tape.
