**PUBLIC NOTICE**  
**BUFFER ZONES FOR TRANSYLVANIA COUNTY POLLING SITES**  
**MARCH 5, 2024 PRIMARY ELECTION**

The following is a list of Transylvania County polling places for the 2024 Primary Election and a description of each buffer zone in which early voting and Election Day electioneering is prohibited. Buffer zones are designated in accordance with G.S. § 163-166.4(a), by the county board of elections. Where practical, the set limit of the zone is 50 feet from the door of entrance to the voting place, measured when that door is closed, but in no event is the limit at more than 50 feet or at less than 25 feet. The poll workers will mark buffer zones during early voting and on Election Day with survey flags, chalk lines, and/or “No campaigning beyond this point” signage. Electioneering volunteers should park away from the polling site main traffic area to ensure adequate voter parking. Political signage can be posted at precinct polling sites 36 hours prior to Election Day as noted below:
